PROTECTING WOMEN'S HEALTH THROUGH LIFE-AFFIRMING, KNOWLEDGE-BASED CARE

## **Take Action**

- Be informed! Medical oversight for women seeking abortion in PA is changing.

Monique\* had taken two at-homepregnancy tests, and both read positive. When she called our center the next day, it was with one goal in mind—to end her pregnancy with an abortion.

When AWC's receptionist Kara answered Monique's call, she shared that while AWC does not perform or refer for abortion, we could schedule an appointment to confirm her **One phone** pregnancy. At a first visit to our center, Monique would be offered a professional grade pregnancy test and a limited ultrasound. Kara's compassion and in search of knowledge helped Monique go from seeking an abortion to booking an appointment to learn more an abortion about her options.

However, Kara didn't end that call with only booking an appointment; she asked Monique the standard health questions to ensure her the best care

experience at AWC. Her answers alerted Kara to several alarming symptoms, so Kara got permission to immediately connect Monique to a member of our professional medical team.

#### HER HEALTH MATTERS

AWC's Medical Services Manager Lea (also one of our sonographers) asked additional guestions to clarify Monigue's symptoms, building trust within minutes. That's when Monique felt comfortable enough to mention that a month prior she had taken the "morning after" pill. Lea began to wonder if Monique's symptoms were related to that pill, but was confused as to how her at-home-pregnancy tests could be positive—especially since the unusual symptoms she was having seemed to indicate she wasn't pregnant! Eventually Monigue also shared she didn't have a primary care doctor who she could go to for help because she didn't really trust doctors.

Before ending the call, Lea advised Monique that if she was experiencing excessive cramping, bleeding, or both, between then and her scheduled appointment at AWC, she should not wait for her appointment but go to the emergency room right away.

### **KNOWLEGE SAVES LIVES**

AWC's Client Services Director Terri called Monique a few days later to confirm her appointment. Monique shared that she had spent the last few days in the hospital and had nearly died. Her symptoms continued to worsen after her call to AWC, so

she pushed aside her fear of doctors, followed our medical team's advice, and had gone to the emergency room.

At the hospital, Monique's ultrasound exam confirmed an ectopic pregnancy, which had caused hemorrhaging severe enough to require a blood transfusion.

Monique thanked the AWC team for essentially saving her life. Our team may not have been in the hospital room, but Monique knew that because we listened, asked questions, and empowered her

to choose to know, her life was spared. One phone call made in search of an abortion changed everything.

If Monique's initial call had reached an abortion provider instead of AWC, she may have been given immediate access to the abortion pill. If she had concluded that her symptoms were due to the abortion pill, it's possible the ectopic pregnancy would have gone untreated until it was too late to save Monique's life.

As abortion medication becomes increasingly easy to obtain without medical oversight, tragic ends to situations like Monique's will likely become more and more common.

Today Monique now knows, if she finds herself in need of life-affirming health services, she can trust AWC to protect her health and empower her with truth. Our purple doors will always be open to her and the many others like her.
