***In the Balance* is not a lecture or a political debate.** *It is a conversation with real consequences.* It is an invitation to stand for life with both clarity and compassion. Throughout the evening, guests will be invited to consider how societal pressures that often conflict with faith and conscience influence ethical decisions and how we are called to respond with understanding, courage, and conviction.

**Dr. John Di Camillo**, bioethicist with the National Catholic Bioethics Center.

**Fr. Stephen Logue**, ethicist and spiritual advisor offering front-line support to individuals navigating complex life decisions. He is also the Bioethics teacher at Lancaster Catholic High School.

**Judge Cheryl Allen**, retired PA Supreme Court judge who will bring a legal and judicial perspective to the ethical challenges facing families today.

Together, they will unpack some of the most pressing moral questions of today. This is not just a night to learn. It is a night to be inspired, equipped, and invited into deeper partnership with the life-affirming mission of **A Woman's Concern**, where truth and compassion meet women and families in their most vulnerable moments.
